 - o Cannot be combined with APR special rates through Audi Finance.
 - o Can be combined with Stackable Cash.

- Fleet customers with valid Fleet Account Number (FAN).
- Customer must have a minimum of 5 vehicles, any make and model, in bona fide fleet service to qualify for a FAN.

Dealer Reimbursement:

Audits:
